1. IPC PRESIDENT'S MESSAGE

This Newsletter features a short introduction message from the new FAI Secretary-General, Stéphane Desprez. Stéphane received a warm welcome to the IPC at the recent Plenary in Lausanne. He contributed positively to Bureau meetings and we can expect enthusiastic support as we move forward on developing initiatives arising from the IPC Strategic Plan.

The media release calling for bidders for the Mondial 2012 has received wide coverage, and interest from targeted bidders is starting to emerge.

A Request for Proposal document is being prepared which will call for the provision of a dedicated electronic scoring system for IPC events for a trial period of three years. Details will be distributed shortly, and Delegates will be requested to alert interested parties in their own countries of this opportunity to become the IPC's electronic scoring system supplier.

The FAI Commission on Airspace and Navigation Systems (CANS) held its Plenary meeting on the weekend following the IPC Plenary. I attended on behalf of IPC. This is still a new Commission finding its way. Of particular interest to those present was the use of environmental issues to protect the loss of airports to housing and other developments. It was recognised that the work of Europe Air Sports is very important to air space provision in Europe, and I would encourage all IPC Delegates in Europe to support this work through membership of the European Parachute Union. What happens in Europe can happen in other parts of the world, and in these busy times, airspace provision for parachuting is becoming under more threat from the growth in commercial aviation.

I would like to take this opportunity to thank IPC Delegates for the trust they have shown in the IPC Bureau for returning it to office at the last meeting. There is now a clear path forward for the next two years, and I can provide an assurance that the IPC Bureau will be working to the agreed plan as hard as it can.

2 PRESS RELEASE FROM IPC THROUGH FAI

In line with the IPC Strategic Plan aim of getting cities and regions to host a Mondial, the Press Release, below, was issued by FAI on 5 February 2010. The Press Release was distributed by e-mail to some 2400 contacts within and outside FAI, including aviation magazines and Sportcal. IPC Delegates who may have contacts in cities or regions which might be interested in hosting a parachuting Mondial are asked to contact the IPC President, Graeme Windsor.

Sportcal, a widely recognised website providing up-to-date and comprehensive information and services to the global sports market, reacted quickly to the Press Release and carried news of it on its website (www.sportcal.com). The FAI subscribed to Sportcal's services several years ago, thus providing visibility to air sports on the market of international sports.



BIDDING UNDERWAY FOR THE FAI PARACHUTING MONDIAL 2012

Lausanne, 5 February 2010

The Fédération Aéronautique Internationale, FAI - The World Air Sports Federation, announced today that bidding has opened to host the FAI Parachuting Mondial in 2012.

The week-long World Championships are staged every two years by the FAI Parachuting Commission (IPC). In 2012 the Championships will take the prestigious form of a **Mondial**, featuring every type of parachute sport (except Paraski and Canopy Piloting) – a total of four exciting, spectacular parachuting events in all, for both teams and individuals.

The host organization receives full rights to income generated by ticket sales and event sponsorship generated by the host organiser. Extensive TV coverage can be expected around the globe.

The chosen venue will be in or close to a large population centre, with all events taking place at a central airfield or open area (e.g. park, hippodrome or sport arena) equipped with a flat, 100 x 150m grass landing zone; adequate spectator capacity; giant screen(s) for transmitting live video footage; suitable parking facilities and public transport access.

Hosts are required to cover technical/organizational costs and provide accommodation, meals and transport for some 600 to 700 athletes and officials.

Bidders are encouraged to "develop visionary proposals that can enhance the scope, presentation and marketing" of the World Championships.

Final bids must be received by 30 June 2010.
