MINUTES

In the Chair: Patrice Girardin, IPC President
Representing the FAI: Jean-Marc Badan

1. WELCOME AND ROLL CALL

IPC President Girardin called to order the 57th Plenary meeting of the IPC at 1000 hours, Saturday, 28 January 2006, at the Scandic Hotel, Stockholm, Sweden, and introduced Swedish Aero Club president John Grubbström, who addressed the Plenary and welcomed the delegates.

IPC President Girardin asked the Plenary to stand for a moment of silence in memory of the skydivers who died while pursuing their sport in 2005. Special mention was made of Mr. William H. Ottley, USA alternate delegate for many years, who passed away December 1, 2005.

President Girardin conducted the roll call of Delegates, including apologies for absentees, approval of proxies, and, verification of Delegate's authority. Roll call showed that 24 delegates were present (**ANNEX A**) and the following four proxies were recognized:
Bulgaria to Poland
Estonia to Finland
Lithuania to Sweden
Slovak Republic to Czech Republic

The Delegates' address list was circulated for its annual update, and will be posted on the IPC website.

2. CONFIRMATION OF MINUTES

Minutes of the 56th IPC Plenary meeting held in Jachranka (near Warsaw), Poland, 29-30 January 2005, were approved and have been published on the FAI/IPC website.

3. 98th FAI GENERAL CONFERENCE - FAI ACTIVITIES REPORT

FAI representative Jean-Marc Badan presented an overview of FAI's activities in 2005, the results of the 98th FAI General Conference held in Paris, France, 11 October 2005, and FAI's plans for 2006. Mr. Badan, attending his first IPC commission meeting, said that the WAG concept will be further developed and the FAI is looking at ways to raise funds.

4. PRESIDENT'S ADDRESS

4.1 President's Report

President Girardin's report was included in the agenda and provided opinions on the World Games, the Olympic games and the many first category events conducted in 2005. Now that the IPC's Olympic dream is over, the IPC must consider whether involvement in the World Games is worthwhile or even financially viable.

4.2 Decisions by the Bureau

President Girardin reported on the IPC Bureau's interim work during 2005, a list of which was included in the Agenda. One decision made by the bureau on 9/28/05 was omitted from the list, a request from CF committee chair Marylou Laughlin for a definition of team make-up during the 2005 World Cup of Canopy Piloting. Additionally, at the IPC bureau meeting before the full plenary met, the bureau decided to act on the request from Ms. Ziara Abud, a

Brazilian citizen, who needed the FAI to issue her a sporting license so she could participate with the World Team attempting to establish a new large formation world record in Thailand. The interim actions were approved by the Plenary.

4.3 **Mission Plan**

President Girardin reported on the status of the IPC Mission Plan and its development, which was included in the Agenda. Topics of the report, and proposed team leaders where appropriate, included:

- Long term IPC goals are to be maintained as long as the WAGs and WGs remain – team leader Graeme Windsor gave a report.
- The mondial structure is to be maintained, with the concept developing into the World Parachuting Championships – team leader President Girardin.
- Synchronization is not longer a task but a responsibility of each committee chair.
- Event development is to be maintained, with a review of the world cup format in an effort to find private organizers, and to integrate continental championships as well as parallel structures such as Asiana – team leader Rainer *Exi* Hoenle.
- IPC needs to manage its own website – team leader Susan Dixon.
- Image capture and handling is to be abandoned, in that technical development is so fast that it is not a worthy investment at such a small scale.
- Sport scoring and vision is important to presentation and is to be maintained; it must become standardized for use in judging and scoring and must be included in the organizer agreements – team leaders Graeme Windsor and President Girardin.
- The financial plan is to be maintained, with the goal of identifying potential sources of income, and the creation of a portfolio – team leader Richard *Buzz* Bennett.
- Archiving on the FAI website has now been assumed by the FAI headquarters.

Norwegian delegate, Pål Bergan, asked that the mission plan on the IPC website be updated to reflect IPC's current thinking.

5. **WORLD GAMES**

Dr. Rainer *Exi* Hoenle, IPC Technical Director for the World Games 2005, briefed the Plenary on the success of the IWGA's 6th World Games, which were conducted in Duisburg, Germany, in July 2005. Parachuting was the only air sports represented in three consecutive WGs and will be the only one in Taipei in 2009. Although it appears skydiving enjoyed great success in the 2005 event, some questions remain. In 2005, landing accuracy, formation skydiving, and freestyle could have been conducted in the large arena with several thousand spectators, but the three events were moved to the canopy piloting site some distance from the arena where the infrastructure existed to conduct the event. Some issues that should be considered by the Plenary:

- Does IPC continue its involvement in the World Games?
- Should skydiving events be in the main spectator arena, even if some disciplines not capable of being conducted in the main spectator event have to be canceled or replaced? Or,
- Should all skydiving events be held at the same location even if retaining some disciplines requires moving away from the main spectator arena? Or,
- Should freestyle be replaced with 2-way canopy formation?

President Girardin ask the plenary a decision to continue or not its involvement in the World Games. By majority, the motion to continue was accepted. The plenary empower the bureau to define a better program including or not the change between freestyle and CF 2way.

A motion to nominate Dr. Rainer *Exi* Hoenle as the IPC Technical Director for the World Games 2009 passed unanimously.

6. WORLD AIR GAMES

FAI representative Jean-Marc Badan briefed the Plenary on the future of the WAG. They remain a priority for the present FAI executive board. IPC will consider its participation once a final plan is developed.

7. GENERAL ISSUES

Several issues were discussed during the open meeting and the following were presented by President Girardin:

- IPC meeting organizer's agreement: a motion to accept the draft in the agenda with the exception that the deposit amount did not apply was approved. Then a motion to require a deposit of €500, to be effective immediately except for Italy '07 bid and France '08 bid, was approved.
- Right of representation for performance records: a motion to allow the bureau to provide proposal to CASI was approved.
- Continental records: Jean-Marc relayed FAI Secretary General Max Bishop's opinion that FAI headquarters does not support the proposal. The proposal to create a continental records program was approved by the Plenary. ASOs will manage the program and the fee for each record is €50 for three or fewer participants and €100 for four or more participants. The basic program concept was approved with the introduction of the SC5 changes later in the minutes.
- IPC web page webmaster: a task force was appointed and includes Ronald Overdijk, Patrice Girardin, Susan Dixon, and Thomas Tuominen. A motion to approve the TF's contracting with an organization/firm/federation to manage the website was approved.
- IPC/FAI relationship: French delegate Gillian Winter proposed to discuss the issue, which required 2/3-majority vote to discuss because it was not in the agenda and the motion was approved. France discussed term of office for bureau members. Ms. Winter proposed language to amend the FAI by-laws so each commission would be responsible for deciding the length of office for each bureau member, rather than have it annually. A motion to empower the bureau to submit the amendment to the CASI was approved.

8. TECHNICAL AND SAFETY

Liam McNulty, alternate delegate from Kenya and member of the T&S committee, reported on the Committee's activities in 2005, which were included in the Agenda, and the results of its open committee meeting. He distributed a report to the Plenary, which included an apology from T&S deputy chair Harro Trepeneau, who could not attend the meeting.

8.1 Annual IPC Safety Survey and other reports

Liam McNulty distributed a CD to the delegates for use by their NACs and technical & safety officers containing many reports including Safety Reports 2004, AAD Reports 2004, AAD Chart 2006, Student Canopy Loading 2006, and more.

9. FINANCE WORKING GROUP

IPC Treasurer and Finance Working Group Chair, Richard *Buzz* Bennett, discussed his report on income, expenditures, and accounts receivable for 2005. The proposed 2006 IPC Budget was presented and the motion to accept it passed unanimously. A motion to convert from US dollars to Euros effective 1 January 2006 at a rate of 1.18 (.8445) was approved. It was agreed that FCE 2006 sanction fees and OA deposits will be paid in euros converted at the time of payment. Three committees asked for discretionary spending money – AE (updating electronic scoring system), CF (camera angle research), and CP (electronic scoring for accuracy and distance). A motion by Australian delegate Graeme Windsor that the budgeted amount of €12,500 for the AE, CF, and CP committee's spending needed endorsement of the SCWG and approval of the bureau passed unanimously.

Treasurer Bennett gave a special to thanks to Bob Card for his service on the committee.

10. FREEFALL STYLE AND ACCURACY LANDING

Committee Chair John Hitchen reported on the committee's activities in 2005, which were included in the Agenda, and addressed the Agenda topics discussed by the committee for 2006.

10.1 4th Anton Malevsky Memorial (AMM) International Cup 2006, the 29th FAI WPC of Freefall Style & Accuracy Landing 2006, along with the 12th FAI WPC of Canopy Formation 2006.

Russian delegate Anatoly Zhironov provided an update on preparations for the event.

10.2 Future WPCs, World Cups, and other First Category Events

Croatia distributed a bid to host the 5th FAI European Freefall Style & Accuracy Landing Championships 2007 in Osijek, Croatia, 4 – 8 September 2007. A 2/3 majority was required to allow the item to be discussed because it was not on the agenda. A motion to allow the discussion passed. Details of the bid include date: 4 – 8 September 2007; entry fees: competitor in both style and accuracy - €90, in accuracy only - €50 (both fees include accommodations, three meals/day, all competition jumps, opening and closing ceremonies and banquet), accompanying personnel - €370 (includes accommodations and three meals/day), late entry fee - €50; aircraft: AN-2 with a Cessna 206/210 as backup. A motion to accept the bid, with the stipulation that a representative from the organizing NAC be present at the next IPC meeting, was approved.

Russia submitted a bid to host the FAI European Championships and the FAI Anton Malevsky Memorial World Cup in Formation Skydiving (4-way Open, 8-way, 4-way female) 2007; FAI European Championships and the FAI Anton Malevsky Memorial World Cup in AE 2007, FAI European Championships and the FAI Anton Malevsky Memorial World Cup in Accuracy Landing 2007 in Stupino, Russia, 6 – 12 August 2007. A 2/3 majority was required to allow the item to be discussed because it was not on the agenda. A motion to allow the discussion was passed but the discussion was deferred until the AE committee report.

10.3 Proposed changes to the Freefall Style and Accuracy Landing Competition Rules

Committee Chair John Hitchen proposed and discussed amendments to the Competition Rules, due to S&A Committee deliberations held prior to the Plenary meeting. The changes were distributed to the Plenary and were approved unanimously.

11. FORMATION SKYDIVING

Committee Chair Fiona McEachern reported on the Committee's activities in 2005, which were included in the Agenda, and addressed the Agenda topics discussed by the Committee for 2006.

11.1 17th WPC in Formation Skydiving (along with the 6th WPC of FR & SK and the 4th WPC of FF), 5 – 11 August 2006, at Gera (Thüringen), Germany.

German delegate Dr. Rainer Exi Hoenle briefed the Plenary on the possibility that the second twin Otter planned for the event may not be available and that they are in negotiation with another aircraft owner. If not able to obtain a second twin Otter, the organizers will obtain an aircraft with similar characteristics of a twin Otter. If an alternate aircraft is used, as a minimum, 4-way open and 8-way will be out of twin Otter. The Plenary was reminded that this report does not alter the existing Organizer's Agreement signed by the IPC and the organizers.

11.2 12th FAI WPC of Canopy Formation 2006, along with the 4th Anton Malevsky Memorial (AMM) International Cup 2006 (4-way FS, Accuracy Landing (male & female), 4-way CF Rotation), and the 29th FAI WPC of Freefall Style & Accuracy Landing 2006, 12 – 20 August 2006, in Stupino, Russia.

Russian delegate Anatoly provided an update.

11.3 Future WPCs, World Cups, and other First Category Events

Russia submitted a bid to host the FAI European Championships and the FAI Anton Malevsky Memorial World Cup in Formation Skydiving (4-way Open, 8-way, 4-way female) 2007; FAI European Championships and the FAI Anton Malevsky Memorial World Cup in AE 2007, FAI European Championships and the FAI Anton Malevsky Memorial World Cup in Accuracy Landing 2007 in Stupino, Russia, 6 – 12 August 2007. Voting to accept the bid was deferred to AE committee report.

11.4 Proposed changes to the Formation Skydiving Competition Rules

Committee Chair Fiona McEachern presented proposed amendments to the Competition Rules, due to FS Committee deliberations held prior to the Plenary meeting, which were distributed to the Plenary. Protest fees will no be €50 instead of \$50. The changes to the rules and the Sporting Code were approved unanimously.

Norway, referring to annex 28 of the agenda, requested that FS rule 4.11 (the rejudgement rule) be removed from the CRs. A secret ballot was taken and the motion to remove the rule was approved.

12. CANOPY FORMATION

Committee Chair Marylou Laughlin reported on the Committee's activities in 2005, which was included in the Agenda, and addressed the Agenda topics discussed by the Committee for 2006.

12.1 12th FAI WPC of Canopy Formation 2006, along with the 4th Anton Malevsky Memorial (AMM) International Cup 2006, and the 29th FAI WPC of Freefall Style & Accuracy Landing 2006, 12 – 20 August 2006, in Stupino, Russia. August 2006, in Stupino, Russia.

Russian delegate Anatoly provided an update.

12.2 Future WPCs, World Cups, and other First Category Events

The committee discussed the possibility of fax meets by which teams from around the world could conduct competitions and have their performance judged by FAI judges, in an effort to promote canopy formation events.

12.3 Proposed changes to the Canopy Formation Competition Rules

Committee Chair Marylou Laughlin proposed and discussed amendments to the Competition Rules due to CF Committee deliberations held prior to the Plenary meeting. A copy of the draft rules for 2006 was distributed to the Plenary and they were approved unanimously.

13. ARTISTIC EVENTS

Committee Chair Ronald Overdijk reported on Committee activities for 2005, which was included in the Agenda, and addressed the Agenda topics discussed by the Committee for 2006.

13.1 6th WPC of FR & SK and the 4th WPC of FF (along with the 17th WPC in Formation Skydiving), 5 – 11 August 2006, at Gera (Thüringen), Germany. An update was provided by German delegate Rainer Hoenle.

13.2 Future WPCs, World Cups, and other First Category Events

Russia submitted a bid to host the FAI European Championships and the FAI Anton Malevsky Memorial World Cup in Formation Skydiving (4-way Open, 8-way, 4-way female) 2007; FAI European Championships and the FAI Anton Malevsky Memorial World Cup in AE 2007, FAI European Championships and the FAI Anton Malevsky Memorial World Cup in Accuracy Landing 2007 in Stupino, Russia, 6 – 12 August 2007. Details of the event include fees: FS (one event) €360/€480, FS (two events) €1030/€650, AE (one event) €790/€410, AE (two events) €910/€530, accuracy €320/€440, accompanying persons €500/€120; aircraft – FS & AE, LET410 airplane or Mi-8 helicopter (the exact aircraft to be

used will be defined during the 58th IPC meeting in January 2007); accuracy, LET410 airplane, AN-2 airplane, Mi-8 helicopter. A motion to accept the bid was approved.

- 13.3 Proposed changes to the Freestyle, Freestyle, and, Skysurfing Competition Rules**
Committee Chair Ronald Overdijk proposed and discussed amendments to the Competition Rules, due to AE Committee deliberations held prior to the Plenary meeting, which were distributed to the Plenary and they were approved unanimously.

14. PARA-SKI

Committee Chair Michael Egger reported on the Committee's activities in 2005, and addressed the topics discussed by the Committee for 2006.

- 14.1 10th WPC of Para-Ski, Zabljak, Montenegro (Yugoslavia), 7 – 12 March 2005**
FAI controller Larry Bagley reported on the success of the event.

14.2 Future WPCs, World Cups, and other First Category Events

A bid from Austria to host the 7th WC & 4th EC of Para-Ski 2008 was presented, details include date: 5-9 March 2008; location: Donnersbachwald, Austria; fees: €490 competitors, €470 juniors, €440 officials, €110 accompanying guests, €50 last entry; (includes jumps, ski course and ski pass, full board); aircraft: helicopter (Ecureuil or Lama). A motion to accept the bid was approved.

A bid from Austria to host the 12th WPC of Para-Ski 2009 was presented, details include date: 10-15 March 2009; location: Donnersbachwald, Austria; fees: €510 competitors, €490 juniors, €460 officials, €420 accompanying guests, €50 last entry; (includes jumps, ski course and ski pass, full board); aircraft: helicopter (Ecureuil or Lama). A motion to accept the bid was approved.

Because there were no bids to host the 11th WPC 2007 in Para-Ski, a motion to empower the Bureau to act on any 2007 WPC bids received approved unanimously.

14.3 Proposed changes to the Para-Ski Competition Rules

Committee Chair Michael Egger proposed and discussed amendments to the Competition Rules, due to Para-Ski Committee deliberations held prior to the Plenary meeting, which were included in the Agenda. A copy of the rules was distributed to the Plenary and approved with one abstention.

15. CANOPY PILOTING

Committee Chair Thomas Tuominen reported on Committee activities for 2005, which was included in the Agenda, and addressed the Agenda topics discussed by the Committee for 2006.

- 15.1 2nd World Cup of Canopy Piloting, Lake Wales, Florida, 7 – 13 February 2005**
Although delayed due to the effects of hurricanes, it was reported as a very successful event.

15.2 3rd World Cup of Canopy Piloting, Stubenberg, Austria, 24 – 28 August 2005

The agenda included the IPC Jury's report, a letter from President Girardin to the Austrian NAC, and a letter from the Austrian delegate, Johann Gritsch. President Girardin declared that the Plenary would not re-try the case or challenge the decision made by the jury, but offered Mr. Gritsch the opportunity to address the Plenary and defend the organizer's position, which he did. Discussion ensued. The Plenary was reminded of the procedures, and Mr. Gritsch asked that the last sentence of his letter ("...absolutely not willing to pay the amount of USD 2,250.00") be removed. When it was agreed that the letter could not be modified, and Mr. Gritsch was not able to suggest a remedy, President Girardin suggested the wording that "no penalty be assessed", which was accepted by Mr. Gritsch. Therefore, Mr. Gritsch proposed a motion, by secret ballot, to have the Plenary reduce the penalty to zero.

The first vote resulted in a tie – 14-14. The second vote count was 15-13, which resulted in the penalty being reduced to zero.

15.3 1st WPC of Canopy Piloting 2006, 23 – 27 August 2006 in Vienna, Austria. The original venue of Stubenberg, south of Vienna, was replaced with Vienna because of the current political environment in Stubenberg.

15.4 Future WPCs, World Cups, and other First Category Events

Australia presented a bid to host the 4th FAI World Cup of Canopy Piloting 2007, details include date: 7-11 November 2007; location: Sydney Skydiving Centre, Picton, NSW; fees: competitors (without accommodations) €520 (includes jumps, lunch, banquet), €50 late entry fee; aircraft: Twin Otter (back-up aircraft PAC XL750). A motion to accept the bid as presented in the agenda was approved.

15.5 Proposed changes to the Canopy Piloting Competition Rules

Committee Chair Tuominen proposed and discussed amendments to the Competition Rules based on Committee deliberations held prior to the Plenary meeting. A copy of rule changes was distributed to the Plenary and the motion to accept the changes was approved unanimously.

16. FAI JUDGING

Committee Chair Doris Merz-Hunziker reported on the Committee's activities in 2005, which were included in the Agenda, and discussed proposed changes to the Sporting Code Section 5, which were distributed to the Plenary. The changes included a provision to provide reimbursement for judge's travel according to a schedule. A reimbursement schedule was presented, which provides for €300 within host country, €400 within Europe and within North America, and, €1000 America-Europe, South America-Europe, Oceania-Europe, Oceania-America, Africa-Europe, Africa-America, Asia-America, and Asia-Europe. A motion to accept the changes was approved unanimously.

16.1 FAI Judges List

The list of FAI Judges for 2006 was verified, per updates sent to Judges Committee Chair Merz-Hunziker by the deadline of 31 December 2005 and is included as **ANNEX B**. Judges Committee Chair Merz-Hunziker nominated the chief judges for 2006 FCEs:

The Plenary unanimously approved the list.

17. SPORTING CODE & IPC INTERNAL REGULATIONS

Committee Chair of the Sporting Code Working Group Graeme Windsor presented the IPC Jury list, from which names will be taken to form juries at FCEs. The new list (**Annex C**) was approved by the Plenary unanimously. The juries and FAI controllers for the following FCEs in 2006-07 were presented to the Plenary and the motion to approve the list for each

17.1 FAI Sporting Code, Section 5

The Secretary of the Sporting Code Working Group, Richard *Buzz* Bennett, presented proposals to amend the Sporting Code, Section 5, which were distributed to the Plenary.

Liam McNulty (Kenya alt. del.) moved that the requirement for certificates of proficiency be retained. The motion failed.

Doris Merz-Hunziker (Switzerland del.) moved that missing a boarding call requires a major penalty rather than the reduced penalty written in the rules. The motion failed.

Ronald Overdijk moved that a non-refundable €500 fine be imposed if a bidder does not follow the time-line for bidding and puts forth a bid at the Plenary. The motion failed.

Rainer Hoenle (Germany del.) moved that no addition bids will be allowed by the 2/3-majorities if any bid meets the required deadline. The motion passed.

Bennett moved that the deposit amounts in the OA schedule 1 be converted to Euros and the text in appendix 1 to schedule 1 be changed. The motion passed unanimously.

Bennett further explained the two-hour time limit for protests (5.2.1 & 5.3.1). A motion to accept the changes was approved.

17.2 IPC Internal Regulations

The changes to the Internal Regulations were included in the Agenda. A request was made by Denmark that the IR annex 2 be changed to allow for awarding the medal to “candidates”. A motion to accept the changes was approved unanimously.

18. ASIANIA

Asiania representative Faye Cox, on behalf of Asiania President Lee Jong Hoon, presented her report on Asiania activities in 2005.

19. AWARDS

19.1 FAI Gold Parachuting Medal

In 2005, Korea nominated Mr. LEE, Jong-Hoon to be awarded the 2005 FAI Gold Medal and his qualifications were included in the Agenda. According to IPC IRs, no delegate or alternate delegate can be awarded this medal. As Mr. Lee is the registered delegate from Korea, no medal was awarded.

19.2 Leonardo da Vinci Diploma

The USA has nominated Mr. Scott Rhodes to be awarded the Leonardo da Vinci Diploma and his qualifications were included in the Agenda. USA's clarified its intent of having the Plenary consider Mr. Rhodes for next year's award.

In 2005, Germany nominated Mr. Marco Pflugar to be awarded the Leonardo da Vinci Diploma and his qualifications were included in the Agenda. In accordance with the by-laws, a secret ballot vote was taken to decide if the Plenary wanted to award a diploma. The motion passed. Therefore, with only one candidate nominated, the Leonardo da Vinci Diploma was awarded to Mr. Marco Pflugar of Germany for his outstanding athletic achievements in competitive parachuting nationally and internationally.

19.3 Faust Vrancic Medal

The Danish Aeronautic Association has nominated Ted Wagner & Larry Hill to be awarded the Faust Vrancic Medal. The two individuals nominated are members of the USA NAC, and the FAI by-laws require that a letter of support from the nominee's NAC be included with the nomination. Although the Danish NAC provided the nomination to the FAI more than 75 days before the Plenary, no notice was given to Denmark or the USA that such a letter was necessary or missing. Therefore the nomination was not accepted.
