## **8.2. Consideration of Revocation of Associate Membership of Egyptian Sport Parachuting and Aeronautics Federation (ESPAF)**

The Aero Club of Egypt (Egypt NAC) requested the following (quote from Annex 8.2.1):

- 1) *The case be added to the General Conference agenda being held in October [update: December] of 2019.*
- 2) *Aero Club of Egypt as the active member for Egypt would like to address the general conference to argue the case and withdraw support of their associated membership.*
- 3) *The associated membership of ESPAF (Egyptian Sport Parachuting and Aeronautics Federation) be put to a vote for revocation.*
- 4) *Return of the IPC (Parachuting) sporting powers to ACE.*

**The General Conference is invited to approve the request of the Egypt NAC regarding this matter.**

## **8.3. Consideration of Applications for Admission of New FAI Members**

#### **8.4. Re-approval of Existing Temporary Members**
