The minimum time to be purchased will be 15 minutes.

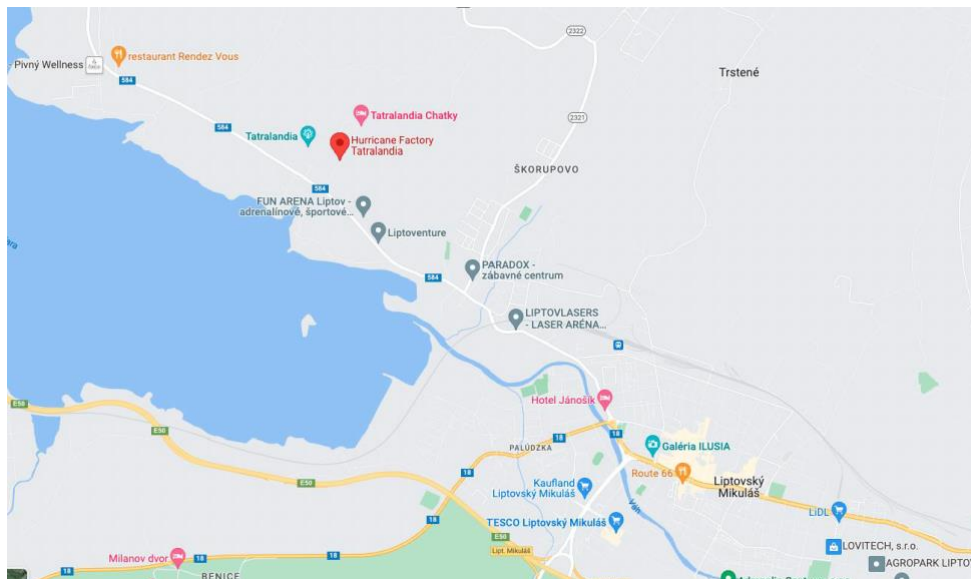
Each Team in each category, whose official registration reaches the Organiser of the competition before the official deadline, will have the opportunity, under the terms and conditions set by the Organiser, to book a maximum of fifteen (15) minutes of Training Flights between 7:00 am and 24:00 pm (local time of the competition) to be completed within the forty-eight (48) hours time period prior to Official Speed Setting Flights. The team must book this time with the Organiser asap before the official registration deadline. After the deadline the Organiser may offer the remaining time to anyone. Junior performers have priority between 08:00 and 18:00

## Transportation:

We provide shuttle transport only for judges and organisers of the competition. However, we advise to competitors to use car rental such as [Europcar Slovakia - Car Hire](#) We have a huge parking lot ready for you right between the tunnel and Liptov arena.

## By train or bus

Kosice, Bratislava and Vienna airports can be reached by train (runs every two-three hours during the day).

Liptovský Mikuláš railway station and bus station are just 3 km from the tunnel. Bus station is situated right beside train station and from there you can take a bus number 13 to Aquapark Tatralandia bus stop ( around 10 minutes ride ). You can see the Liptov arena and tunnel from there

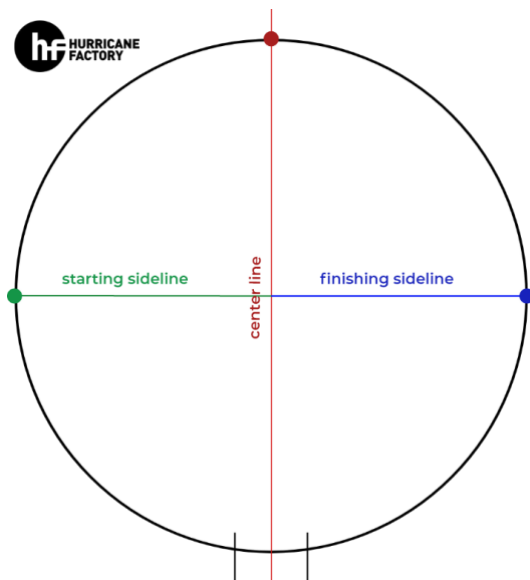
## Food

All competitors will have lunch every day during the competition. Those who stay in Holliday village will eat there. Those who are accommodated in Maladinovo will have lunch there and those who will be accommodated out of those two will have lunch at Holliday Vilage Tatralandia.

All competitors and official delegates will have Closing ceremony dinner as well. We will give you more info on that matter on the spot.

## Tunnel details

Lines of the tunnel:



Door of the chamber



The tunnel has 4.3 m diameter and can produce wind up to 270 km/h.

The height of the glass is 6 m.

Doors Measurements are 186 cm in height and 60 cm wide.

Centerline is in center on the opposite side of the doors.

The tunnel has video system with 4 cameras and different rent angles.

(Top, Bottom, Centerline, sideline+ring).

There will be quality cameras available for judging and streaming according the competition rules.

All videos are immediately transferred to a video server of the judging system.

## Windtunnel facilities

The facility consists of one building with a basement and two floors, which include many multi-purpose rooms ( video rooms, training rooms, changing rooms and the Hurricane Factory Bar with direct view on tunnel.

- VIP room ( Video, judge room with direct view on tunnel)
- Balcony ( direct view on tunnel)
- Changing room n. 1 ( showers, toilets )
- Changing room n. 2 ( sport training, video, showers, changing room )
- Briefing room ( video, showers )

## Liptov Arena

Because of the tunnel building size, it's not big enough for all people, we are providing the Liptov arena as a house of competition

Liptov arena is a multi-sport complex situated 150 m from the tunnel. There are 4 large changing rooms. The sitting area is 230 seats on the main tribune and 300 seats will be ready to use under the stage with LED panel with the live stream. There will be 4 areas for competitors:

- creeping area with up to 5 rings
- Chillzone with huge LED panel with Live streaming
- bar with refreshments
- sports zone (floorball, basketball, little fitness area)

There also will be a couple of vendors selling skydiving gear

## Final registration

The final date of registration is 31st March.

The registration and sanction fee must be paid by 31.3.2023.

## Music and video submissions

### Music:

The music must be legal! either by purchasing a license VIA *Clicknclear*, using original music or "public domain"(classic) .  
upload your music to :

The music file must be exactly as needed for the performance.

3 short beeps followed by one long beep will automatically be added to each file to serve as a countdown to the athletes, judges and audience. You should therefore not add one yourself .

Please use the email you used for your ClicknClear licenses if you licensed your music through ClicknClear. Once logged in, you will be asked to upload your music. Please upload a maximum file length of 1 minute 45 seconds in .mp3 or .wav format.

If you are using music that is in the Public Domain, you will need to confirm this on the system and accept that you are liable for any misinformation you have provided to us.

Once music has been uploaded, the system will recognize the music being used



and check if there is a license for it. If your music is licensed, you do not need to do anything further. If your music is not licensed, you may be able to license the music via ClicknClear.

Please click 'License Missing Tracks'.

If you licensed your music but did not do so via ClicknClear, you can submit your license agreement PDF on the same page as the audio uploader. If the music has not been identified please contact [support@clicknclear.com](mailto:support@clicknclear.com).

All competitors wishing to perform with music must bring their own music headsets.

### Arrival

After you arrive to Liptovský Mikuláš and you accommodate your self we kindly ask your team captain or head of the delegation to come to the tunnel reception to get the gift packages, wristbands and all pieces of information of the competition. Gift packages will be ready from 17th of April.

### Antidoping

The Anti-Doping Program may take place at the event. If so - the doping tests are carried out by the official Anti-Doping organization or sample collection provider recognized and approved by World Anti-Doping Agency (WADA).

The selection of athletes would be according to the 2021 FAI Anti-Doping Rules, which are based on 2021 WADA Code and are available at

<https://www.fai.org/anti-doping-rules-procedures> .

After receipt of notification until arrival at the point of doping control the selected competitors will be always accompanied by a chaperone assigned by the sample collection authority. The selected competitor may be accompanied by a person of their choice (team doctor, coach or head of delegation). If the Organizing Committee does not provide participants with accreditation with the photo on it, the selected athlete will be required to provide a valid passport or identity card at the point of doping control.

**NOTE:** *As a competitor, you may have an illness or condition that requires a particular medication. If this medication contains a substance on the WADA Prohibited List, you may be granted a Therapeutic Use Exemption (TUE) giving*

you permission to take it. The application for TUE shall be submitted prior to the competition to FAI. For more information please see : <https://www.fai.org/page/anti-doping-therapeutic-exemptions> or contact [antidoping@fai.org](mailto:antidoping@fai.org) directly.
